Specific Auction Terms and Conditions

Bidding time extension:	Bidding time for an item shall be extended automatically by 2 minutes, if a bid is made up to one minute before end of bidding time.
Buyers premium/VAT:	Buyers will be charged a commission on the respective highest bid. The amount may vary depending on the item and project. On the item details page you will find the respective buyer's commission.
Minimum Prices:	For some lots of the auction minimum prices have been set! Should the minimum prices not have been reached, the seller of these items will be informed about the highest bids after the end of the auction sale. He will then decide whether the lots will be sold for the prices realized. If the seller agrees to sell an item to the highest bidder despite of the fact that the reserve price was not met, the potential buyer will be informed of the decision within two days from the auction's end. The highest bidder shall remain bound by his bid, regardless of whether or not the contact has been established up to 48 hours after the end of the auction containing the item for which the bid was made. If a lot should not have met the minimum price yet, this is mentioned in the bidding box.
VAT Switzerland:	Buyers from Switzerland must pay the Swiss VAT to the auctioneer.
VAT other countries:	<p>Buyers without a valid VAT ID or tax number will receive an invoice with the Swiss VAT valid at the time of invoicing. A refund of the paid VAT is not possible in this case.</p> <p>Buyers with a valid VAT ID will receive an invoice with a deposit amounting to the Swiss VAT valid at the time of invoicing. A refund of this deposit is only possible if the necessary export documents are made available within 2 weeks after invoicing.</p>
Further information:	<p>Collection by forwarder or self collector by own car or truck:</p> <p>Refund of the deposit is only possible if a valid VAT ID and all necessary export documents are made available within 2 weeks after invoicing. If no valid VAT ID is made available, a refund of the deposit is not possible.</p>
Origin & Preferences:	Please note that we cannot normally issue certificates of origin and preference documents, such as EUR-1, A. TR, or declarations of origin on the invoice for the items in the auction, as the previous documents required by law are not available to us. The unauthorized issue and use of preference documents is considered tax evasion or of aiding and abetting tax evasion.
CE Certificate & EU Conformity:	Please note that not all items in this auction come with EU certificates of conformity and CE certificates. In exceptional cases, missing EU certificates of conformity or CE certificates may be requested for individual heavy machines. The costs incurred will be charged to the buyer.
Exclusion of warranty:	All assets are used and will be sold "as is, where is". No warranty or guarantee on any asset!
Customs declarations:	<p>If the Surplex (Schweiz) AG is the legal exporter as per customs law, all export declarations are to be issued in the name of Surplex (Schweiz) AG. The issuance of export declarations in the name of Surplex (Schweiz) AG is done by Surplex (Schweiz) AG itself only or by an authorized representative which has to be nominated by Surplex itself.
